Subject: Appointment of Ombudsperson(s) as provided in the University Grants Commission (Redressal of Grievances of Students) Regulations, 2023

Respected Madam/Sir,

As you are aware, the UGC notified the University Grants Commission (Redressal of Grievances of Students) Regulations, 2023 in the Official Gazette on 11 April 2023 (available on UGC website). The Universities were requested to appoint Ombudsperson(s) within 30 days of the notification of the Regulations vide letter dated 12 April 2023. This was followed with several reminders.

The Universities are required to comply with the Regulations by constituting Students Grievance Redressal Committee (SGRC) any by appointing Ombudspersons.

However, it is understood that some universities are yet to comply with the Regulations. The matter is being viewed seriously.

I write to request you again to promptly appoint Ombudsperson(s) and implement other provisions of UGC Regulations on or before 31 December 2023.

Since enough opportunities have been provided to the Universities, it has been decided to publish the names of defaulting Universities on the website of UGC after 31 December 2023.

In case a defaulting University desires to make a representation against inclusion of its name in the list of defaulting universities, it may be sent to the Secretary, University Grants Commission, Bahadurshah Zafar Marg, New Delhi-110002, before 31 December 2023.

It may be added that in case of a continuous non-compliance, the UGC may be constrained to take punitive action(s) against such Universities as per provisions of the Regulations.
