Child Protection Policy (CPP)

1. Policy	Child Protection Policy (CPP)
2. Definition of a child	A child is defined as any person under the age of 18 years.
3. Purpose of Child Protection Policy (CPP)	The University of Trans-Disciplinary Health Sciences and Technology (TDU), has a zero tolerance approach to child exploitation or abuse towards a child and is committed towards protecting the safety and well-being of children. TDU has adopted this Child Protection Policy ("CPP") requiring the faculty, research fellows, consultants, administrative staff, housekeeping, security and garden and others to conduct themselves appropriately with the children who participate in school programs / workshops / visits as well to take reasonable measures to ensure the safety of such children. This policy reinforces TDU's commitment to the rights of the children and their safety and
	wellbeing and aims to define the behaviours and actions that constitute child abuse or maltreatment. Additionally, TDU will lay out the expectations for behaviours' the scope of application of the policy and guidelines for reporting and redressal.
4. Scope	The CPP is applicable to all the staff of TDU (part-time and full-time employees of TDU) and any other person who has been bound to the CPP as per their contractual agreement with TDU.
5. What constitutes child abuse or maltreatment	Child abuse or maltreatment constitutes all forms of physical and/or emotional ill-treatment, sexual abuse, neglect or negligent treatment or commercial or other exploitation, resulting in actual or potential harm to the child's health, survival, development, or dignity in the context of a relationship of responsibility, trust or power (Source: A report of the consultation on child abuse prevention, WHO, Geneva, 29-31 March 1999).

Listen to children and respect their views. Ensure that physical contact with a child is respectful, culturally appropriate and
	 Prohibited Behaviour and Actions Do not use language or behaviour towards children that is inappropriate, harassing, abusive, sexually provocative, demeaning, intimidating, offensive, discriminatory or culturally insensitive.
	 Establish an atmosphere that fosters the development of children through actions and words. Always take permission from children before taking their photos or videos.
	 The implementing team attend all the applicable training sessions and workshops on the CPP conducted by the TDU and implement the lessons learnt from such sessions and workshops.
	 Keep all personal information about children or their parents/guardians confidential and secure and ensure that such information is dispensed to only those individuals who are legitimately entitled to it.
